



Memorandum of Understanding
Between

National Council for Cement and Building Materials,

and
Madhav Institute of Technology & Science, Gwalior



National Council for Cement and Building Materials, Ballabgarh (hereinafter referred to as **NCCBM**) is the premier body under the administrative control of Ministry of Commerce and Industry, Government of India, for technology development, transfer, continuing education, and industrial services for cement and construction industries. Geographically, NCCBM has its corporate centre and main laboratories located at Ballabgarh, another well-established regional centre at Hyderabad, and project offices at Ahmedabad and Bhubaneshwar.

Madhav Institute of Technology & Science, Gwalior Madhya Pradesh (hereinafter referred to as MITS-Gwalior), is... a premier Institute providing world class Education in Engineering & Technology, Architecture & Planning, Management and Computer applications. This Memorandum of Understanding (MoU) between NCCBM and MITS-Gwalior Pradesh, is signed with the objective of fostering collaboration between the two institutions to promote academic and research interactions, and to provide for the following:

1. NCCBM would endeavor to facilitate the internship training to MITS-Gwalior students of Engineering & Science (Chemistry, Electrical, Mechanical, Chemical and Civil Engineering).
2. NCCBM and MITS-Gwalior will facilitate sharing of laboratory facilities, library facilities, and materials including software and other components developed in-house for research purpose only, as per mutually agreed terms and conditions.
3. NCCBM and MITS-Gwalior will exchange ideas, materials and manpower with a view to enhancing mutually beneficial R&D activities, which would have a bearing on addressing national issues and problems.
4. NCCBM and MITS-Gwalior will explore the possibility of jointly conducting seminars / workshops / conferences at national and international levels, in areas of mutual interest.
5. MITS-Gwalior shall recognize NCCBM as an external research centre and scientist & engineers of NCCBM working on R&D Projects may be registered for PhD Programme at MITS-Gwalior under the joint supervision of a Ph.D guide from NCCBM and MITS-Gwalior. Principal guide may either be from NCCBM or MITS-Gwalior.

NCCBM and MITS-Gwalior will put in place adequate and reasonable measures to keep confidential information secure to prevent any unauthorized use. There will be no restriction on the publication of the results of collaborative research, except where such outcome has implications for the security of the State. NCCBM and MITS-Gwalior will be free to carry out follow-up research independently. Rights regarding publications, patents, royalty, ownership of software/design/products etc., developed under the scope of this MoU, shall be decided by mutual discussion. Separate policy documents in this regard will be framed, consistent with the rules and regulations of NCCBM and MITS-Gwalior.

NCCBM and MITS-Gwalior will jointly develop and devise implementation strategies and time-bound action plans to effectively meet the desired objectives and goals. Financial arrangements for each specific activity will be decided on a case-to-case basis and brought on record in each case after due approval from heads of NCCBM and MITS-Gwalior.

A joint Coordination Committee consisting of a nominee of Director General, NCCBM as Chairman, and a nominee of Director, MITS-Gwalior as Co-Chairman, and two nominees each from NCCBM and MITS-Gwalior, would coordinate and monitor the academic and research programmes and all related operational matters within the framework of the academic regulations of MITS-Gwalior and the objectives of NCCBM.

This MoU is effective from the date of signing and will remain so for a period of five years. This MoU may be extended for another period on mutually agreeable terms and conditions.

Either NCCBM or MITS-Gwalior shall be at liberty to terminate this MoU by providing a prior written notice of six (6) months. However, in case of such early termination, both NCCBM and MITS-Gwalior will have to ensure that none of the ongoing educational, training, or research programmes will be affected.
